
Halifax Helps Awards Over \$48,000 in 2015!

HEMC awarded \$7,560.28 in Bright Ideas educational grants in 2015 to teachers in Warren and Halifax counties. This program is offered by all 26 of NC's cooperatives to support teachers in K–12 by funding innovative ideas for classroom projects. Grant applications are accepted April 1 through September 18th and teachers can apply individually or as a team at www.NCBrightIdeas.com.

Pennies make dollars and this is proven true each and every month with the success of our Halifax Helps Program! To-date approximately 8,700 members participate in our Operation RoundUp Program, thus allowing their electric service bill to be "rounded up" each month to the nearest whole dollar amount. Last year \$48,881.83 was awarded in financial assistance through this program to local organizations.
